10 A JOINT CITY/COUNTY RESOLUTION

11 REQUESTING LEGISLATIVE FUNDING TO STUDY THE FEASIBLE WATER SUPPLY
12 ALTERNATIVES AND TECHNIQUES TO MAXIMIZE AND ENHANCE EFFECTIVE DIVERSION OF
13 COUNTY AND CITY WATER RIGHTS AT BUCKMAN.

15 WHEREAS, the County and the City are experiencing significant growth and acknowledge the value and
16 need to promote effective water resource management; and

17 WHEREAS, the County and the City own and operate water utilities that service Santa Fe and
18 surrounding areas; and

19 WHEREAS, the County and the City have long range plans to develop adequate facilities to meet their
20 respective potable water supply needs that include determining and addressing the potable water supply needs of
21 the surrounding areas; and

22 WHEREAS, the County and the City have the need to develop water supply sources and to acquire
23 waters rights to further their goals of providing water supply to meet present and future demands; and

24 WHEREAS, the County and the City have created the Regional Planning Authority in order to address
25 resource sharing and management of resources of focusing on water quality and supply issues; and

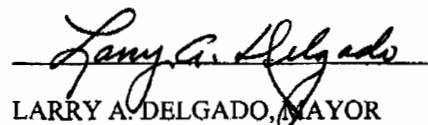

3 Department in the sum of \$81,250.

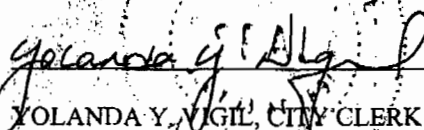
4 **NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF**

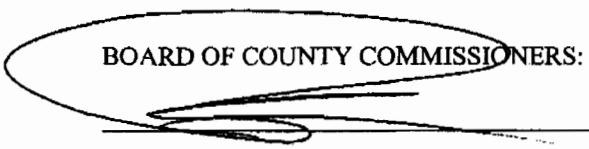

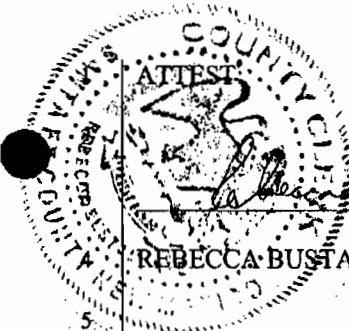
