A RESOLUTION SELECTING THE METHOD OF PAYMENT OF THE FEDERAL FOREST RESERVE FUNDS DISTRIBUTION FOR SANTA FE, COUNTY NEW MEXICO

WHEREAS, THE STATE OF NEW MEXICO RECEIVES FEDERAL FOREST RESERVE FUNDS AND DISTRIBUTES SAID FUNDS TO COUNTIES WITH NATIONAL FORESTS, AND;

WHEREAS, THE FEDERAL LAW RELATING TO THE FEDERAL FOREST RESERVE FUNDS DISTRIBUTION HAS HAD SIGNIFICANT CHANGES THAT REQUIRE COUNTIES TO SELECT A METHOD OF PAYMENT OF THEIR RESPECTIVE FUNDS, AND;

WHEREAS, SANTA FE COUNTY STANDS TO RECEIVE A LARGER DISTRIBUTION OF FUNDS BY SELECTING THE FULL PAYMENT, TITLE I METHOD OF DISTRIBUTION OVER THE TRADITIONAL 25% DISTRIBUTION METHOD; THEREFORE,

BE IT RESOLVED THAT THE SANTA FE BOARD OF COUNTY COMMISSIONERS SELECTS THE NEW PAYMENT FORMULA, FULL PAYMENT UNDER PUBLIC LAW 106-393 WITH 100% DEDICATED TO TITLE I, TRADITIONAL USES (ROADS).
