A RESOLUTION CREATING THE SCOPE OF SERVICES AND DIRECTING THE EXPENDITURE OF CAPITAL FUNDS

WHEREAS, the Santa Fe County Board of Commissioners, sitting as the Board of Finance, construct and approve the budget instrument for County operations annually, and

WHEREAS, the Board of County Commissioners has budgeted in the current 2001/2002 budget document the expenditure of \$250,000 dollars for one time capital projects to be approved by the Board of County Commissioners; and

WHEREAS, the Board of Commissioners desire to create the scope for the expenditure of the above referenced funds.

NOW THEREFORE BE IT RESOLVED, that the following scope and process be created in order to expend this General Fund Expenditure of \$250,000, within the current 2001/2002 fiscal year.

Scope of Services

The following services/projects will be eligible for funding under the General Fund Capital Outlay Fund authorized under the County Commission budget. Services/Projects funded by the Board of County Commissioners are one-time allocations and are not recurring commitments.

Minimum Requirements:

Members of the Board of Commissioners may sponsor any proposal within the following scope:

Submittal of a concise proposal which provides a clear description of the proposed program/project, a budget describing how the requested funds will be expended, contact person, non-profit status if applicable, timeline for completion. The proposed project will be submitted for funding on the attached form, see Attachment A.

Funding Areas:

- A. Health Initiatives:
 - 1. Mental Health Programs
 - 2. Substance Abuse Programs
 - 3. Community Services related to Health.

- B. Match Grants/Challenge Grants:
 - 1. Requests for funds for community purposes which will be utilized to leverage other funds from other sources.
 - 2. Seed money requests with strong possibilities for phased completion.
- C. Studies/Services:
 - 1. Water System Analysis
 - 2. Utilities Development
 - 3. Road Improvement Analysis
 - 4. Drainage System Analysis
 - 5. Codification of Documents
 - 6. Strategic Planning Initiatives
- D. Community Facilities Development:
 - 1. Parks
 - 2. Community Centers
 - 3. Senior Centers
 - 4. Libraries
 - 5. Teen Centers
- E. Facilities Improvements:
 - 1. Energy Efficiencies
 - 2. Space Reconfigurations
 - 3. Safety Initiatives
- F. Economic Development:
 - 1. Program Development
 - 2. Marketing
 - 3. Infrastructure Development

BE IT FURTHER RESOLVED, that these capital funds may be expended in two cycles, as defined below:

- A. First Funding Cycle be submitted for review and approval on November 27, 2001, Board of County Commission Administrative Meeting; and
- B. Second Funding Cycle be submitted for review and approval on the March 26, 2002, BCC Administrative Meeting; and
- C. The funds will be divided equally by Commissioner.
