DETAILED JUSTIFICATION FOR REQUESTING BUDGET ADJUSTMENT (If applicable, cite the following authority: State Statute, grant name and award date, other laws, regulations, etc.):

1) Please summarize the request and its purpose.

Request is to reduce the operating transfer from the General Fund (101) to the Road Projects Fund (311) for CR 84-G and CR 73 Road Improvements project. (This request completes the transfer decrease that originated on Resolution 2001-146.)

The request to reduce the budget for CR 84-G is based upon actual cash balance remaining from fiscal year 2001. An estimated balance was rolled over into fiscal year 2002.

The decrease for CR 73 Road Improvements Project is due to the Co-Op Agreements from the New Mexico State Highway and Transportation Department being less than the estimated amount budgeted.

• 2) Why was this request not included in the Fiscal Year 2002 Operating Budget?

The Public Works Department budgeted these projects based on estimates during preparation of the FY 2002 Operating Budget.
