11 TEMPORARILY RENEWING AND EXTENDING THE FRANCHISE AGREEMENT

20 issuance and regulation of franchise agreements; and

21 WHEREAS, the Board of County Commissioners intends to adopt an ordinance setting forth

22 the policy for the issuance and regulation of franchise agreements; and

23 WHEREAS, Jemez Mountains Electric Cooperative, Inc. and the Board of County

24 Commissioners desire to continue operating under the terms and conditions of the above


25 franchise agreement until a new agreement can be issued.

4 extended and shall remain in force until replaced by a subsequent agreement or nullified by  
5 other action of the Board of County Commissioners.
