WHEREAS, the Housing Authority has reviewed the final rule for Pet Ownership in Public Housing and has created a Pet Policy.

SANTA FE COUNTY HOUSING AUTHORITY PET OWNERSHIP POLICY

1901258

Residents of Santa Fe County Housing Authority may own and keep pets within the property of their dwelling unit. The Housing Authority must approve of any animal except for caged birds, fish, and Seeing Eye, Hearing Ear, or other assistance animals. Animals that provide assistance, support, or service persons with disabilities and are needed as a reasonable accommodation to such individuals, are not "common household pets," covered by this policy. Rather, they are Assistive animals, necessary to provide the individual with an opportunity to use and enjoy the dwelling to the same extend as residents without disabilities. This exclusion applies to such animals that reside in public housing, as that term is used in 24CFR 960.703, and such animals that visit these developments.

The following general conditions must be met.

- 1. Pet size is restricted to small animals less than twenty (20) pounds.
- 2. The number of pets per household will be limited to one (1) animal per household. In no case shall a tenant have more than one pet in the unit, except for fish, birds, and small caged mammals. The Housing Authority reserves the right to limit the number of fish, birds and small caged mammals, and use its discretion in doing so.
- 3. Pet owners will be required to pay a \$100.00 pet deposit, which will be refunded at termination of occupancy if there are no damages caused by the animal.
- 4. Before any pet can be admitted to a dwelling unit, the tenant must submit the following documentation to the Housing Authority: A signed statement by a licensed veterinarian, verifying that the pet is in good health, has no communicable diseases, has been immunized, and in the case of dogs and cats, has been neutered, or spayed. Pet owners must also provide the Housing Authority with a copy of the license before the pet is allowed on Housing Authority property.
- 5. All pets (except for caged birds, fish, and assistance animals) must be registered with the Santa Fe County Housing Authority. Before the pet is brought onto the premises and at the annual re-examination of the tenant's lease, the tenant must provide proof of shots and a current license.
- 6. All pets must be housed within the tenant's property.
- 7. All cats and dogs must be kept on a leash when not in the unit and on Housing Authority property and must be accompanied by a person able to control them at all times. Animals may not be let out on their own to run loose or prowl the neighborhood.
