A RESOLUTION ESTABLISHING MINIMUM APPRAISER QUALIFICATIONS FOR PROPERTIES PURCHASED UNDER THE COUNTY'S WILDLIFE, MOUNTAINS, TRAILS AND HISTORIC PLACES PROGRAM

WHEREAS, voters in Santa Fe County approved General Obligation Bonds establishing funding for the "Wildlife, Mountains, Trails and Historic Places Program," ("Program") on November 3, 1998 and November 7, 2000; and

WHEREAS, the County adopted Resolution No. 1998-105 on September 29, 1998 and Resolution No. 1998-132 on November 24, 1998 establishing an Open Land and Trails Planning and Advisory Committee ("Committee"); and

WHEREAS, the Committee advises the County on priority projects for acquisition under the Wildlife, Mountains, Trails and Historic Places Program; and

WHEREAS, to fulfill the requirements of the General Obligation Bonds, properties approved for acquisition by the BCC must have a certified appraisal report establishing fair market value; and

WHEREAS, a MAI designated appraiser is the highest designation available for appraisers and MAI appraisers are trained in the valuation and evaluation of commercial, industrial, residential and other types of properties; and

WHEREAS, properties recommended for acquisition may contain significant cultural, archeological, natural and historical resources requiring a more complex level of appraisal evaluation.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners (BCC) of Santa Fe County that for properties containing significant archeological, historical, cultural and natural resources or zoned other than vacant, residential land and being considered for acquisition under the County's Wildlife, Mountains, Trails and Historic Places Program shall be appraised by an MAI designated appraiser.
