**A RESOLUTION APPROVING THE SUBMITTAL OF AN APPLICATION FOR
AN INTEREST FREE LOAN TO THE NEW MEXICO TAXATION AND
REVENUE DEPARTMENT THROUGH THE DEPARTMENT OF FINANCE
AND ADMINISTRATION AND STATE BOARD OF FINANCE.**

Whereas, the Board of County Commissioners is authorized to borrow funds and/or issue bonds for the financing of public projects for the benefit of the Board of County Commissioners; and

Whereas, the New Mexico Taxation and Revenue Department ("Department") has instituted a program for the financing of property reassessment projects and has developed an application procedure whereby the Board of County Commissioners and County Assessor may submit an application ("Application") for financial assistance to the Department for such reassessment projects; and

Whereas, the Board of County Commissioners intends to conduct an aerial mapping project in order to acquire digital orthoimagery and topographic map data for the benefit of the Board of County Commissioners and its citizens; and

Whereas, the Application prescribed by the Department has been completed and submitted to the Board of County Commissioners and this resolution approving submission of the completed Application to the Department for its consideration and review is required as a part of the Application.

**NOW THEREFORE BE IT RESOLVED BY THE SANTA FE COUNTY BOARD
OF COUNTY COMMISSIONERS:**

Section 1. That all action heretofore taken by the Board of County Commissioners and the officers and employees thereof directed toward the Application and the undertaking of the aerial mapping project be and the same is hereby ratified, approved and confirmed.

Section 2. That the completed Application submitted to the Board of County Commissioners has been amended to increase the loan amount to \$250,000.00 with a five (5) year interest free repayment term is hereby approved and confirmed as amended.


Section 4. This resolution shall take effect immediately upon its adoption.




