A JOINT CITY/COUNTY RESOLUTION

**REQUESTING LEGISLATIVE FUNDING TO STUDY THE FEASIBLE WATER SUPPLY
ALTERNATIVES AND TECHNIQUES TO MAXIMIZE AND ENHANCE EFFECTIVE DIVERSION OF
COUNTY AND CITY WATER RIGHTS AT BUCKMAN.**

WHEREAS, the County and the City are experiencing significant growth and acknowledge the value and need to promote effective water resource management; and

WHEREAS, the County and the City own and operate water utilities that service Santa Fe and surrounding areas; and

WHEREAS, the County and the City have long range plans to develop adequate facilities to meet their respective potable water supply needs that include determining and addressing the potable water supply needs of the surrounding areas; and

WHEREAS, the County and the City have the need to develop water supply sources and to acquire waters rights to further their goals of providing water supply to meet present and future demands; and

WHEREAS, the County and the City have created the Regional Planning Authority in order to address resource sharing and management of resources of focusing on water quality and supply issues; and

1 WHEREAS, the County and the City recognize the need and desire for additional funding and are hereby
2 requesting matching funds to a grant received by Santa Fe County from the Housing and Urban Development
3 Department in the sum of \$81,250.



4 NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF


