Request is to transfer investment earnings realized on bond proceeds during Fiscal Year 2001 from the General Obligation Bond (Series 1997) Fund to the GO Debt Service Fund (401) as required by bond indenture.

The bond document requires investment earnings accumulated in the Bond Proceed Fund (350) to be transferred annually at the end of the fiscal year to the Debt Service Fund (401) and used to pay debt service.




