Request is to transfer investment earnings realized on bond proceeds in Fiscal Year 2001 from the General Obligation Bond (Series 1999) – Open Space Fund (385) to the GO Debt Service Fund (401).

The bond document requires investment earnings accumulated in the Bond Proceed Fund (Fund 385) to be transferred annually at the end of the fiscal year to the Debt Service Fund (401) and used to pay debt service.




