AUTHORITY REGARDING THE REGIONAL WATER SYSTEM FEASIBILITY
STUDY AND ENVIRONMENTAL ASSESSMENT FOR CUATRO VILLAS
MUTUAL DOMESTIC WATER USERS ASSOCIATION**

WHEREAS, the State of New Mexico Legislature has allocated funds through the New Mexico Environment Department for the purposes of a regional small community water system feasibility study and environmental assessment;

WHEREAS, the project was funded with no local match and is further identified through project numbers SAP-02-1453-GF and SAP 03-0346-STB;

WHEREAS, the Land Use Department Director should be designated as the official representative authorized to submit final and any documents pertaining to the project; and

WHEREAS, the Santa Fe County Manager should be designated as the signatory authority to sign and submit reimbursement requests.

NOW, THEREFORE, BE IT RESOLVED that the Board of County Commissioners (BCC) of Santa Fe County supports the proposed project and designates the Land Use Director as the official representative authorized to submit final and any documents pertaining to the project; and designates the Santa Fe County Manager as the signatory authority authorized to sign and submit reimbursement requests.
