Request is to transfer investment earnings realized on bond proceeds during fiscal year 2006 from the General Obligation Bond (Series 1997) Fund to the GO Debt Service Fund (401) as required by bond indenture.





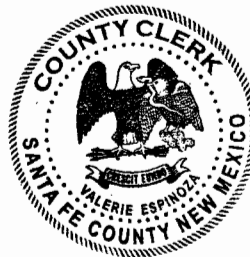
