### A RESOLUTION IN SUPPORT OF THE CHIMAYO CHILE PROJECT THROUGH THE PARTICIPATION AND MEMBERSHIP OF THE CHIMAYO CHILE COORDINATION COMMITTEE

---

**WHEREAS**, Santa Fe County (the County) recognizes the Chimayo Chile Coordination Committee (CCCC) as the primary proponent in the community's pursuit of the preservation, documentation, cultivation, processing, trademark and marketing of Chimayo Chile as an agricultural product to provide an economic base for the community; and

**WHEREAS**, the CCCC membership will consist of one representative from the following organizations: Rio Arriba County, Santa Fe County, Santa Fe Institute for Native Hispanic Culture, Santa Cruz Land Grant, Santa Cruz Irrigation District, Chimayo Youth Conservation Corp., Chimayo Boys and Girls Club, Inter-faith LEAP, Chimayo Chile Farmers, Inc., and the four Acequias; and

**WHEREAS**, it is in the County's interest to participate in community efforts to promote economic development; and

**WHEREAS**, the County shall select one person, a non-elected official, to serve as the representative to the committee; and

**WHEREAS**, the representation to the committee must be reaffirmed annually by the respective organizations.

**NOW BE IT THEREFORE RESOLVED** that the Board of County Commissioners of Santa Fe County pledges its full support and participation in cooperation with the CCCC in the attainment of this goal, and authorizes CCCC to represent the County on behalf of the project.




