DETAILED JUSTIFICATION FOR REQUESTING BUDGET ADJUSTMENT (If applicable, cite the following authority: State Statute, grant name and award date, other laws, regulations, etc.):

- 1) Please summarize the request and its purpose.
Request is to transfer \$73,027.51 of investment earnings realized on bond proceeds in Fiscal Year 2007 (April 2007 thru June 2007) from the General Obligation Bond Fund Series 2001 (353) to the GO Bond Debt Service Fund (401) as required by bond indenture. Resolution 2007-93 approved at the June 26, 2007 BCC meeting transferred \$242,895.69 of investment earnings realized for July 2006 thru March 2007.
- 2) Why was this request not included in the Fiscal Year 2007 Operating Budget?
The bond document requires investment earnings accumulated in the Bond Proceeds Fund (353) to be transferred annually at the end of the fiscal year to the Debt Service Fund (401) and used to pay debt service.
- 3) Is the transfer recurring or non-recurring and what are the future funding impacts of this request?
This request is anticipated to be non-recurring for this fiscal year. It is anticipated that whatever investment income is earned in Fiscal Year 2008 will be transferred from the proceeds fund to the debt service fund at the end of the fiscal year.
