### **A RESOLUTION SUPPORTING COLLABORATION BETWEEN SANTA FE COUNTY AND OTHER PARTICIPATING LOCAL GOVERNMENTS IN ORDER TO DEVELOP APPROPRIATE AGREEMENTS REGARDING OWNERSHIP AND OPERATION OF THE EAST MOUNTAIN REGIONAL ANIMAL CARE FACILITY**

---

**WHEREAS**, a planning committee consisting of interested citizens, representatives from Santa Fe, Bernalillo and Tarrant counties, and representatives from the municipalities of Moriarty and Edgewood, has been successful in securing a business lease for twenty acres located at section 16 in the Town of Edgewood; and

**WHEREAS**, the Town of Edgewood agreed to be the fiscal agent for a \$150,000 special appropriation from the New Mexico Legislature to plan, design and construct a regional animal care facility; and

**WHEREAS**, it is anticipated that participating local governments will work together to draft appropriate agreements for the ownership and operation of the regional animal care facility; and

**WHEREAS**, the firms of Kells & Craig Architects (Albuquerque, NM) and Connolly Architects (Austin, TX) have been retained to conduct feasibility planning services and preliminary design services for the regional animal care facility.

**NOW THEREFOR BE IT RESOLVED THAT** Santa Fe County will work with the participating local governments in a good faith effort to draft appropriate agreements regarding the ownership and operation of the regional animal care facility.
