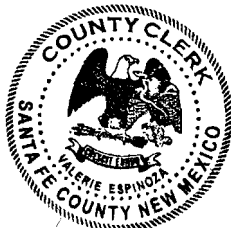

Location: 9.33 Miles of County Road that connects NM State Road 14 and NM State Road 41.

Scope of Work: This project incorporates the engineering and road improvement construction of the remaining 4.9 miles of unpaved section of County Road 42. New construction will include improving the current conditions to utilize 2 eleven foot driving lanes, improvement in road drainage and construction of erosion control structures.
