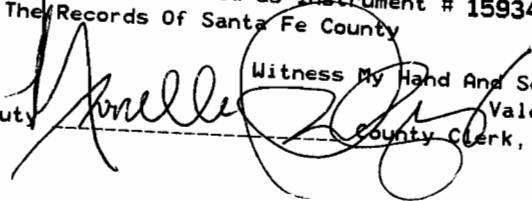

IMPROVEMENTS ON COUNTY ROAD 17 (MARTIN ROAD), NEW MEXICO

WHEREAS, the Department requires that the Board provide a Resolution requesting funding and attach a detailed project breakdown per funding source; and

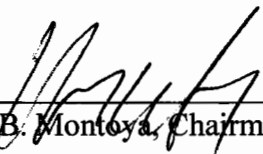

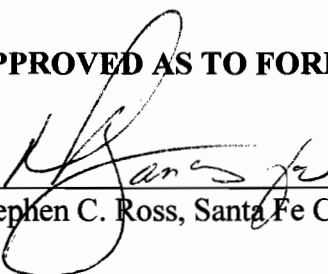

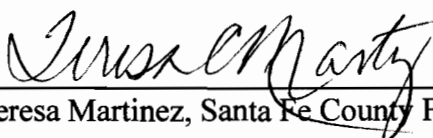
