A RESOLUTION RESCINDING AND REPLACING RESOLUTION NO. 2011-112 **REQUESTING PARTICIPATION IN THE NEW MEXICO DEPARTMENT OF** TRANSPORTATION 2011-2012 LOCAL GOVERNMENT ROAD FUND (LGRF), FOR **ROAD IMPROVEMENTS ON COUNTY ROAD 52 (LAS ESTRELLAS), IN SANTA FE** COUNTY, NEW MEXICO, UNDER THE COUNTY ARTERIAL PROGRAM **PROJECT NO. CAP-5-12(464)**

WHEREAS, pursuant to Section 67-3-28.2 NMSA 1978, assistance for local road construction and repair is available through the New Mexico Department of Transportation Local Government Road Fund (LGRF) County Arterial Program (CAP); and

WHEREAS, to obtain funds from the LGRF-CAP Program a local government must agree, pursuant to Section 67-3-32 NMSA 1978, to provide matching funds; and

WHEREAS, the County of Santa Fe applied for funding from the LGRF-CAP Program for pavement rehabilitation and improvements of CR 52 (Las Estrellas) in Santa Fe County, New Mexico (the "Project"). The total project cost, including twenty-five percent (25%) Santa Fe County participation, is \$141,547.00; and

WHEREAS, Santa Fe County concurs with the State of New Mexico to utilize awarded funds from the LGRF-CPA Program for pavement rehabilitation and improvements of CR 52 (Las Estrellas) in Santa Fe County, New Mexico ; and

WHEREAS, the Board of County Commissioners of Santa Fe County supports the Project and will provide twenty-five percent (25%) of the funds for the Project as required under the LGRF-CAP Program.

NOW THEREFORE, BE IT RESOLVED that the Santa Fe Board of County Commissioners agree to execute the LGRF-CAP Program Cooperative Agreement to obtain funds for pavement rehabilitation and improvements of CR 52 (Las Estrellas) in Santa Fe County, New Mexico, support the pavement rehabilitation and improvements of CR 52 (Las Estrellas) in Santa Fe County, New Mexico, and provide twenty-five percent (25%) matching funds for this Project in the amount of \$35,386.75.
