REQUESTING PARTICIPATION IN THE NEW MEXICO DEPARTMENT OF
TRANSPORTATION 2011-2012 LOCAL GOVERNMENT ROAD FUND (LGRF)
PROGRAM, FOR ROAD IMPROVEMENTS ON COUNTY ROAD 67 (OLD SANTA FE
TRAIL), ALSO KNOWN AS "CAMP STONY ROAD," IN SANTA FE COUNTY, NEW
MEXICO, UNDER THE SCHOOL BUS ROUTE PROGRAM

WHEREAS, pursuant to Section 67-3-28.2 NMSA 1978, assistance for local road construction and repair is available through the New Mexico Department of Transportation Local Government Road Fund (LGRF) School Bus Route (SB) Program; and

WHEREAS, to obtain funds from the LGRF-SB Program a local government must agree, pursuant to Section 67-3-32 NMSA 1978, to provide matching funds; and

WHEREAS, the County of Santa Fe applied for funding from the Program for pavement rehabilitation and improvements of CR 67 (Old Santa Fe Trail), also known as "Camp Stony Road," in Santa Fe County, New Mexico (the "Project"). The total project cost, including twenty-five percent (25%) Santa Fe County participation, is \$118,784.00; and

WHEREAS, Santa Fe County concurs with the State of New Mexico to utilize awarded funds from the LGRF-SB Program for pavement rehabilitation and improvements of CR 67 (Old Santa Fe Trail), also known as "Camp Stony Road," in Santa Fe County, New Mexico; and

WHEREAS, the Board of County Commissioners of Santa Fe County supports the Project and will provide twenty-five percent (25%) of the funds for the Project as required under the LGRF SB Program.

NOW THEREFORE, BE IT RESOLVED that the Santa Fe Board of County Commissioners agree to execute the LGRF-SB Cooperative Agreement to obtain funds for pavement rehabilitation and improvements of CR 67 (Old Santa Fe Trail), also known as "Camp Stony Road," in Santa Fe County, New Mexico, support the pavement rehabilitation and improvements of CR 67 (Old Santa Fe Trail), also known as "Camp Stony Road," in Santa Fe County, New Mexico, and provide twenty-five percent (25%) matching funds for this Project in the amount of \$29,696.00.
