RESOLUTION NO. 2011- 31

A RESOLUTION DIRECTING STAFF TO APPLY FOR A \$400,000 FEDERAL ARRA  
GRANT TO ASSIST IN THE REMEDIATION OF THE NEW FIRST JUDICIAL DISTRICT  
COURTHOUSE SITE AND AUTHORIZING THE COUNTY MANAGER TO EXECUTE  
ANY AND ALL DOCUMENTS NECESSARY FOR THE GRANT APPLICATION

WHEREAS, Santa Fe County ("the County") has undertaken the construction of a  
new court facility to house the Steve Herrera District Courthouse on approximately 2.4 acres  
of property ("the Property") owned by the County at the corner of Montezuma Avenue and  
Sandoval Street in Santa Fe;

WHEREAS, the project has required remediation of petroleum contamination that has  
migrated onto the County's property from adjacent properties;

WHEREAS, the County is interested in mitigating the costs of the remediation of the  
project site and has identified a source for financial assistance from a Federal American  
Recovery and Reinvestment Act (ARRA) grant totaling \$400,000 which is administered by  
the Environmental Protection Agency (EPA) through the New Mexico Environment  
Department, Ground Water Quality Bureau (NMED/GWQB);

WHEREAS, the County is currently working with the NMED/GWQB to develop the  
appropriate documents for the grant application outlined above but the necessary documents  
will not be not finalized at the time of the March 8, 2011 Board of County Commissioners  
meeting;

WHEREAS, the County wishes to allow for a timely and efficient process for the  
submittal of the grant application; and

WHEREAS, the Board desires to direct staff to apply for the ARRA Grant to assist  
in remediation of the Courthouse site and authorizes the County Manager to execute any and  
all documents necessary for the grant application.

NOW, THEREFORE BE IT RESOLVED AS FOLLOWS:

1. The Board directs staff to apply for an ARRA Grant totaling \$400,000 to assist in  
remediation of the Courthouse site and authorizes the County Manager to execute any and all  
documents necessary for the grant application.




