RESOLUTION NO. 2011-53

A Resolution Authorizing Public Sale of Seized DWI Personal Property that Has Been in the Possession of the Santa Fe County Sheriff's Department for More than Ninety (90) Days, in Accordance with State Statutes

WHEREAS, the Santa Fe County Sheriff's Department has had in its possession for over ninety days seized property that came into its possession lawfully, which property is identified in the inventory attached hereto as Exhibit A; and

WHEREAS, the seized properties (i) have been forfeited or adjudicated to the Santa Fe County DWI Seizure Program; (ii) are not needed for use in obtaining a conviction; and (iii) are not needed for any other public purpose; and

WHEREAS, NMSA 1978, Section 29-1-14(A) (2003) authorizes the public sale of such property, the proceeds of which will be paid to the Santa Fe County Treasurer for credit to the Santa Fe County Law Enforcement Operations Fund.

NOW THEREFORE BE IT RESOLVED by the Board of County Commissioners of Santa Fe County that the public sale of the seized properties inventoried on Exhibit A is hereby authorized.


