**A RESOLUTION TO NAME THE STANLEY FIRE DISTRICT STATION
LOCATED AT #30 WEST KINSELL AVENUE IN THE TOWN OF STANLEY IN
HONOR OF RETIRED DISTRICT CHIEF HERMAN C. SENA**

WHEREAS, Herman C. Sena was born on April 2, 1940, in Lemitar, New Mexico;

WHEREAS, Mr. Sena joined the United States Army 3rd Division in 1958, and following his honorable discharge he worked in the building construction industry for 35 years;

WHEREAS, Mr. Sena married Judy Sena and together they have eight children and nine grandchildren;

WHEREAS, in September 1998, Mr. Sena fulfilled his lifelong dream of becoming a firefighter by joining the Stanley Volunteer Fire District of the Santa Fe County Fire Department;

WHEREAS, Mr. Sena acquired certification in Firefighter I and is trained in Emergency Medical Services, Incident Command, Wildland Firefighting, Hazardous Materials Response, and Emergency Vehicle Operations;

WHEREAS, Mr. Sena was elected as Chief of the Stanley Volunteer Fire District in 2000, and served in that capacity for a decade prior to his retirement in 2010;

WHEREAS, throughout his firefighting career Mr. Sena has been recognized by his peers in the County Fire Department for his outstanding firefighting and leadership skills;



HEREBY RESOLVES AND PROCLAIMS AS FOLLOWS:**



PASSED, APPROVED, AND ADOPTED this 31st day of May 2011, by the Board of County Commissioners of the County of Santa Fe.


