# A RESOLUTION AMENDING RESOLUTION NO. 2011-79, TO CORRECT ERRORS TO EXHIBIT A

WHEREAS, Resolution 2011-79, adopted by the Board of County Commissioners established a new Water Service Rate and Fee Schedule; and

WHEREAS, it is now necessary to correct an error in Rate Schedule 1, Rate Schedule 2 and Rate Schedule 6 to add the intended and discussed "per 1000 gallons" to the Water Usage Charge per Month tables and to eliminate the category of Government/Institutional Association.
