**A RESOLUTION OF SUPPORT FOR COUNTY PARTICIPATION IN THE
NEW MEXICO DEPARTMENT OF TRANSPORTATION (NMDOT) YEAR
2012/2013 LOCAL GOVERNMENT ROAD IMPROVEMENT FUND
PROGRAM (LGRF) COOPERATIVE PROJECT AGREEMENT PROJECT NO.
SP-5-13(184) FOR PAVEMENT REHABILITATION/IMPROVEMENTS ON
DINKLE ROAD IN SANTA FE COUNTY, NEW MEXICO**

WHEREAS, pursuant to NMSA 1978, Section 67-3-28.2, assistance for local road construction and repair is available through the New Mexico Department of Transportation from the Local Government Road Improvement Fund (LGRF);

WHEREAS, the County of Santa Fe applied for funding from the New Mexico Department of Transportation Local Government Road Improvement Fund (LGRF) for pavement rehabilitation/improvements on Dinkle Road as designated on Exhibit A, attached hereto and made a part hereof by reference (the Project);

WHEREAS, The total project cost (including 25% county participation) is \$83,045.00;

WHEREAS, the County of Santa Fe will utilize awarded funds from the LGRF for the Project;

WHEREAS, to obtain funds from the Local Government Road Improvement Fund (LGRF) Program, a local government must agree to provide matching funds pursuant to NMSA 1978, Section 67-3-32;

WHEREAS, the Board of County Commissioners of Santa Fe County supports the Project and will provide 25% of the funds for the Project.

NOW THEREFORE, BE IT RESOLVED that the Santa Fe County Board of County Commissioners agree to execute the Local Government Road Improvement Fund (LGRF) Program Cooperative Project Agreement to obtain funds for Pavement Rehabilitation/Improvements on Dinkle Road in Santa Fe County, New Mexico as designated on Exhibit A; and Supports the Pavement Rehabilitation/Improvements of Various County Roads in Santa Fe County, New Mexico, and will provide matching funds for this Project in the amount of \$20,761.00


