A RESOLUTION AUTHORIZING AND SUPPORTING AN INFRASTRUCTURE
CAPITAL IMPROVEMENTS PLAN FOR
SANTA FE COUNTY

WHEREAS, Santa Fe County recognizes that the financing of public capital projects has become a major concern in New Mexico and nationally;

WHEREAS, in times of scarce resources, it is necessary to find new financing mechanisms and maximize the use of existing resources;

WHEREAS, systematic capital improvements planning is an effective tool for communities to define their development needs, establish priorities and pursue concrete actions and strategies to achieve necessary project development;

WHEREAS, the process contributes to local and regional efforts in project identification and selection in short and long range capital planning efforts;

WHEREAS, the Santa Fe County Infrastructure Capital Improvements Plan (ICIP) has been developed with the hard work of citizens, staff and Elected Officials participating in a series of community meetings.

NOW THEREFORE BE IT RESOLVED that the Board of County Commissioners of Santa Fe County (the BCC) hereby authorizes and adopts Exhibit A, attached hereto and made a part hereof, as the list of capital projects for inclusion in the Santa Fe County FY 2014-2018 ICIP.




