Board of County Commissioners Resolution No. 2012-165

**A RESOLUTION AUTHORIZING THE SANTA FE COUNTY MANAGER
TO PROVIDE UP TO TWO HUNDRED SEVENTY-FIVE THOUSAND
DOLLARS (\$275,000) IN FUNDING FOR THE PURCHASE OF SECURED
FURNISHINGS AND FIXTURES FOR THE NEW FIRST JUDICIAL
DISTRICT COURT BUILDING**

WHEREAS, Santa Fe County has constructed a new courthouse for the First Judicial District Court;

WHEREAS, the new courthouse is nearing completion but still requires furnishings and fixtures, that include but are not limited to, computer hardware, copiers, printers, hardwired cubicles, and permanent furnishings and fixtures in order to make the courthouse fully functional;

WHEREAS, the First Judicial District Court does not have sufficient funding to acquire all necessary furniture to move into the new facility upon substantial completion;

WHEREAS, the New Mexico Board of Finance has approved the amount of \$275,000 for the purchase of additional equipment and furniture for the courthouse;

WHEREAS, the Administrative Office of the Courts has expressed a willingness to collaborate and work cooperatively with Santa Fe County to provide financial support for the purchase of permanent furnishings and fixtures for the courthouse;

WHEREAS, the City of Santa Fe has also expressed a willingness to collaborate on parking for the facility and its inhabitants;

WHEREAS, irrespective of any statutory obligation, New Mexico counties are empowered to provide assistance to other governmental entities such as the Administrative Office of the Courts, and at the County's election as is customary with law enforcement and fire equipment, equipment and furnishings for the Steve Herrera First Judicial District Courthouse could be purchased by the County and surplussed to the Judiciary;

WHEREAS, it is in the best interests of the County and the taxpayers for all parties involved to partner so that the new facility is functional and can be occupied as quickly as possible;






