**A RESOLUTION OF SUPPORT FOR COUNTY PARTICIPATION IN THE
NEW MEXICO DEPARTMENT OF TRANSPORTATION YEAR 2012
STATEWIDE TRANSPORTATION IMPROVEMENT PROGRAM
COOPERATIVE PROJECT AGREEMENT NO. S100120 FOR PRELIMINARY
ENGINEERING OF THE NE/SE CONNECTORS IN SANTA FE COUNTY,
NEW MEXICO**

WHEREAS, pursuant to Section 67-3-28.2, NMSA 1978, assistance for local road construction and repair is available through the New Mexico Department of Transportation (NMDOT) for the Statewide Transportation Improvement Program (STIP);

WHEREAS, the County of Santa Fe (the County) applied for funding from the NMDOT STIP to fund preliminary engineering of the NE/SE Connectors in Santa Fe County, New Mexico (the "Project");

WHEREAS, the total project cost (including 14.56% county participation) was projected at \$500,000.00;

WHEREAS, the Project was funded through the STIP with a requirement that the County provide matching funds pursuant to Section 67-3-32, NMSA 1978;

WHEREAS, a Cooperative Project Agreement (Santa Fe County Contract No. 2012-1049, Control Number S100120) was executed by NMDOT and the County on March 9th, 2012;

WHEREAS, the Board of County Commissioners of Santa Fe County supports the Project and, will provide the promised 14.56% of the funds for the Project as required under the STIP; and

WHEREAS, NMDOT requires a resolution confirming the commitment of the County to provide the requisite matching funds.

NOW THEREFORE, BE IT RESOLVED that the Santa Fe County Board of County Commissioners agrees to provide matching funds of 14.56% which equates to \$72,800 to be used in conjunction with the \$427,200 provided by NMDOT for the Project.
