CAPITAL IMPROVEMENT PLAN FOR SANTA FE COUNTY AND  
ASSOCIATED WAIVER OF REQUIREMENTS OF RESOLUTION 2013-26**

**WHEREAS**, Santa Fe County recognizes that the financing of public capital projects has become a major concern in New Mexico and nationally;

**WHEREAS**, in times of scarce resources, it is necessary to find new financing mechanisms and maximize the use of existing resources;

**WHEREAS**, systematic capital improvements planning is an effective tool for communities to define their development needs, establish priorities and pursue concrete actions and strategies to achieve necessary project development;

**WHEREAS**, the process contributes to local and regional efforts in project identification and selection in short and long range capital planning efforts; and


**WHEREAS**, Santa Fe County's Infrastructure Capital Improvements Plan (ICIP) has been developed from citizen input through a series of community meetings, and the work of County staff and Elected Officials from various levels of government.

**NOW THEREFORE BE IT RESOLVED** that the Board of County Commissioners of Santa Fe County hereby authorizes and adopts Exhibit A attached hereto, as Santa Fe County's list of capital projects for inclusion in the Santa Fe County FY 2015-2019 Infrastructure Capital Improvements Plan (ICIP).

**BE IT FURTHER RESOLVED** that the Board of County Commissioners ranks Projects No. 1, 2, 3, 4 and 5 as the priority ranking for the FY 2015-2019 ICIP.




