  - a.-b.) The Fire Department requested a renovation to the Hondo Fire Station #1 to include an additional apparatus bay, renovations to the existing bay, and a new pro-panel roof for the station. The design of the renovations/additions is complete and the project is ready to bid. Staff is requesting that \$4,766 of GOB 2009 funds and \$170,201' of GOB 2011 funds be budgeted to pay for the construction.
  - c.-d.) The new Glorieta Fire Station is currently under design. Preliminary cost estimates show that the station will cost approximately \$1,000,000. Staff is requesting that \$421,838 of Capital Outlay GRT and \$656,317 of GOB 2011 funds be budgeted for the construction of the station.
