RESOLUTION No. 2019- 14 -HB**

**A RESOLUTION APPROVING THE CONTINUED RESIDENCY OF POLICE
OFFICERS AT THE VALLE VISTA AND SANTA CRUZ PUBLIC HOUSING
NEIGHBORHOODS TO PROVIDE SECURITY FOR PUBLIC HOUSING
RESIDENTS**

WHEREAS, 24 CFR Section 960.505 allows public housing agencies to authorize police officers who would not otherwise be eligible for occupancy in public housing to reside in a public housing dwelling unit; and

WHEREAS, the occupancy of a public housing dwelling unit by a police officer must be for the purpose of increasing security for public housing residents; and

WHEREAS, the Santa Fe County Housing Authority Board (Board) has on multiple occasions adopted resolutions approving the occupancy of public housing dwelling units at the Santa Cruz, Valle Vista and Jacob D. Martinez Public Housing Neighborhoods; and

WHEREAS, the Santa Fe County Housing Authority (Housing Authority) has determined that placing police officers in its public housing neighborhoods has increased security for public housing residents by decreasing criminal activity in the neighborhoods; and

WHEREAS, the Housing Authority has developed an Implementation Plan and a Law Enforcement Officer Dwelling Lease Agreement as required the US Department of Housing and Urban Development (HUD); and

WHEREAS, the Implementation Plan and the Law Enforcement Officer Dwelling Lease Agreement clarify the selection process, procedures and the terms of occupancy for police officers to reside in public housing dwelling units.

NOW, THEREFORE, BE IT RESOLVED that the Board hereby authorizes the continued occupancy by police officers of unit 20A Sierra Place North at the Valle Vista Public Housing Neighborhood and unit 144 Camino de Quintana at the Santa Cruz Public Housing Neighborhood to provide increased security for public housing residents.
