ORDINANCE NO. 2008-15

**SANTA FE COUNTY REGIONAL TRANSIT GROSS RECEIPTS TAX
ELECTION.**

Section 1. An election on the question whether the County Regional Transit Gross Receipts Tax shall be presented to the registered qualified electors of Santa Fe County New Mexico coincident with the general election on November 4, 2008.

Section 2. The County Clerk shall, at least one time, not more than twelve (12) days and not less than seven (7) days prior to the Election date, give notice of the Santa Fe County Regional Transit Gross Receipts Tax Election question by publishing and posting the following Proclamation in the County in accordance with Section 1-11-1 through 1-11-3 NMSA 1978.

NOTICE IS HEREBY GIVEN that at the general election (the "Election") to be held in Santa Fe County, New Mexico ("the County") on Tuesday, the 4th day of November, 2008, there will be presented for vote to the qualified registered electors of the County the following question:

Shall there be imposed a County Regional Transit Gross Receipts Tax at a rate of one-eighth of one percent (1/8%) to finance the operational costs and capital expenditures of passenger transportation in the North Central Regional Transit District?

No ballot on the County Regional Transit Gross Receipts Tax election shall be received unless, on the date of the election, the person offering to vote is a registered, qualified elector of the County. The registration books of Santa Fe County shall be closed by the County Clerk at 5:00 p.m. on October 7, 2008, except as otherwise provided by law. Any person otherwise eligible to vote as a qualified elector and not currently registered may register prior to such time at the Office of the County Clerk, Santa Fe County, New Mexico.

All registered, qualified electors in Santa Fe County, New Mexico, shall be entitled to vote at the election. Absentee voting shall be permitted as authorized by the Absentee Voter Act, Section 1-6-1, et seq., NMSA 1978, as amended and supplemented.

The vote shall be canvassed as provided in Section 1-13-1 NMSA 1978 et. seq. and pursuant to Section 1-13-13(C) NMSA 1978 the County Clerk shall submit the canvass to the State Canvassing Board which pursuant to Section 1-13-15 NMSA 1978 shall declare the results of the election.

If any section, paragraph, clause or provision of this Ordinance shall for any reason be held to be invalid or unenforceable, the invalidity or unenforceability of such section, paragraph, clause or provision shall not affect any of the remaining provisions of this Ordinance.

This Notice shall be published as required by law."

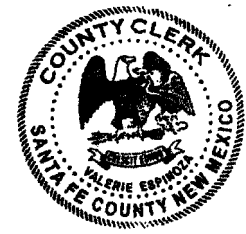
