## AN ORDINANCE DECLARING LA CIENEGA AND LA CIENEGUILLA AS A TRADITIONAL HISTORIC COMMUNITY UNDER STATE LAW

---

WHEREAS, a petition has been presented to the Board of County Commissioners requesting the designation of La Cienega and La Cieneguilla as a traditional historic community under state law; and

WHEREAS, the petition has been referred to the County Clerk and the County Attorney for review and consideration for sufficiency; and

WHEREAS, the County Clerk and the County Attorney have reviewed the petition in light of the state statutory requirements and reported that it is sufficient pursuant to NMSA 1978, Section 3-21-1; and

WHEREAS, the Board of County Commissioners of Santa Fe County has certified the petition as valid.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF SANTA FE COUNTY THAT:

1. The areas identified on the attached map as the Villages of La Cienega and La Cieneguilla
  - a. are unincorporated areas of Santa Fe County;
  - b. are identifiable villages, communities, neighborhoods or districts that are documented as being in existence for more than 100 years;
  - c. include structures or landmarks associated with the identity of the areas traditionally known as the Villages of La Cienega and La Cieneguilla, and are areas with distinctive character or traditional qualities that can be distinguished from surrounding areas or new development in the vicinity.

WHEREFORE, as of the effective date of this ordinance, the areas identified on the attached map as the Villages of La Cienega and La Cieneguilla are declared a Traditional Historic Community under state law.

PASSED, ADOPTED AND APPROVED this 9 day of May, 2000, by the Santa Fe County Board of County Commissioners.


