AN ORDINANCE

ADOPTING THE SANTA FE COUNTY REDISTRICTING PLAN, AMENDING ORDINANCE NO. 1989-10, AND REPEALING ORDINANCE NO. 1992-7, TO REASSIGN PRECINCTS ACCORDING TO THE FIVE COMMISSION DISTRICTS, IN ACCORDANCE WITH THE 2000 U.S. CENSUS AND ACCORDING TO COUNTY REDISTRICTING

WHEREAS, Santa Fe County Ordinance 1989-10 enumerates the five commission districts and sets forth those precincts which comprise those commission districts; and,

WHEREAS, Santa Fe County Ordinance No. 1992-7 reassigned precincts according to the five commission districts, in accordance with the 1990 Census; and,

WHEREAS, the lines dividing and setting forth the five Commission Districts for the County of Santa Fe have been redrawn in accordance with the 2000 U.S. Census.

NOW THEREFORE, be it ordained that the Santa Fe Board of County Commissioners hereby adopts a redistricting plan based on the 2000 U.S. Census, repeals Ordinance No. 1992-7, and that Santa Fe County Ordinance No. 1989-10, Section 2, is hereby deleted, and the following is inserted in its place:

SECTION 2 COUNTY COMMISSION DISTRICTS

District 1 – 1,2,3,4,5,6,7,8,9,10,22,23,26,27,28,30,36,40,58,59,60,61,79

District 2 – 11,20,21,24,25,31,32,33,34,43,44,45,66,80,82,83

District 3 – 12,15,16,17,18,19,62,64,67,72,73,84,85,86

District 4 – 13,35,37,41,42,46,47,48,50,51,52,53,54,55,57,68,76,77,81

District 5 – 14,29,38,39,49,56,63,65,69,70,71,74,75,78


This Ordinance shall become effective the 18th day of January, ~~2001~~ 2002.
