# SANTA FE COUNTY Ordinance Nos. 2008-18

## AN ORDINANCE AMENDING ORDINANCE NOs. 1996-16, 2004-1, and 2006-12 BY REVISING THE BOUNDARY OF THE VILLAGE OF AGUA FRIA TRADITIONAL HISTORIC COMMUNITY

WHEREAS, Ordinance Nos. 1996-16, 2004-1 and 2006-12 amended the boundary of the Village of Agua Fria Traditional Historic Community (the THC) and provided that property owners could request inclusion in the THC; and

14 WHEREAS, several property owners holding property contiguous to the THC have requested 15 inclusion in the THC; and

17 WHEREAS, staff in the County of Santa Fe Land Use Department have examined the tracts of land proposed for inclusion in the THC and have determined that the property is appropriate for 18 inclusion because it was previously designated by the Board of County Commissioners in the 19 original issuance of the Agua Fria Traditional Historic Community Ordinance, to be part of an 20 identifiable village that was documented as being in existence for more than 100 years, was an 21 unincorporated area of Santa Fe County, included structures or landmarks associated with the 22 23 identity of the area traditionally known as the Village of Agua Fria, and was an area with a 24 distinctive character and/or traditional quality that could be distinguished from surrounding areas 25 or new development in the vicinity.




