AN ORDINANCE

AMENDING ARTICLE 1 OF THE ENTRANOSA WATER COOPERATIVE NON-EXCLUSIVE FRANCHISE (BEING ORDINANCE NO. 1981-8 AS AMENDED BY ORDINANCE 1982-10) ALLOWING FOR AN EXPANSION OF ITS SERVICE AREA BOUNDARY TO INCLUDE: ALL OF SECTIONS 3, 4, 5 AND 6, T10N, R7E, NMPM, LOCATED IN SOUTHWEST SANTA FE COUNTY,

BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF SANTA FE:

Section 1. The grant of Franchise of the Entranosa Water Cooperative is amended as follows:

Article 1. Grant of Franchise. In addition to the grants of franchise in Ordinance 1981-8, and in Ordinance 1982-10, the County of Santa Fe, New Mexico (referred to in this Ordinance as "County") grants to ENTRANOSA WATER COOPERATIVE (referred to in this Ordinance as "Cooperative") a nonexclusive franchise for the collection, treatment, pumping, storage, transmission, distribution and sale of water within the following described area: Located in or along the exterior boundaries of Sections 3, 4, 5, and 6


1 in Township 10 North, Range 7 East, NMPM, all lying within




