ORDINANCE NO. 2021-05

AN ORDINANCE AMENDING ORDINANCE NO. 2018-4 (AN ORDINANCE ESTABLISHING SANTA FE COUNTY UTILITY WATER SERVICE RATES AND CHARGES AND REPEALING ALL PRIOR WATER SERVICE RATES AND CHARGES) TO UPDATE WATER SERVICE RATES AND CHARGES THROUGH USE OF UTILITY EXPANSION CHARGES

**BE IT ENACTED BY THE BOARD OF COUNTY COMMISSIONERS
("BOARD") OF SANTA FE COUNTY ("COUNTY"):**

1. Section 11.F of Ordinance No. 2018-4 is hereby deleted in its entirety and replaced with the following:

F. Utility Expansion Charge (UEC).

Customers requesting new water service will be assessed a one-time charge based on the size of the meter; however, the charge for increasing the size of an existing meter shall reflect only the increase in the size of the meter. The charge for each meter service size shall be determined by multiplying the 5/8-inch utility expansion charge by the applicable meter equivalency units (MEU). The utility expansion charge is payable upon submittal of the application.

4-inch	25.00	\$79,125
6-inch	50.00	\$158,250
8-inch	80.00	\$253,200
10-inch	115.00	\$363,975

2. Except as amended by this Ordinance, Ordinance No. 2018-4 shall remain in effect.

3. The effective date of the amendments to Ordinance No. 2018-4 adopted by this Ordinance shall be (30) days after this Ordinance is recorded with the County Clerk.

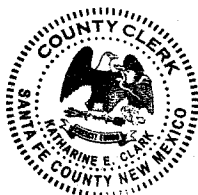
