ORDINANCE NO. 2022 - 04

AN ORDINANCE AMENDING THE SOLID WASTE AND RECYCLING
MANAGEMENT ORDINANCE, NO. 2014-10 TO CLARIFY WHEN SERVICE FEES
ARE REQUIRED FOR USE OF CONVENIENCE CENTERS AND TO AUTHORIZE
THE BOARD OF COUNTY COMMISSIONERS TO AUTHORIZE FREE SOLID WASTE
DISPOSAL DAYS BY RESOLUTION

BE IT ENACTED BY THE BOARD OF COUNTY COMMISSIONERS ("BOARD")
OF SANTA FE COUNTY ("COUNTY"):

Section 1. The title and first paragraph of Section 13(A) of Ordinance No. 2014-10 is hereby amended to read as follows:

Section 13(A). Service Fees for Use of Convenience Centers.

Except for the recycling of recyclable material, as provided in an agreement approved by the Board of County Commissioners, on free solid waste disposal days authorized by resolution of the Board of County Commissioners pursuant to subsection (C) of this Section 13(A), and for Santa Fe County operations as determined by the County Manager, disposal of solid waste at Convenience Centers requires the payment of service fees, through the purchase and use of permits or bag tags. The recycling of recyclable material is free and does not require a recycling permit. Solid waste fees are adopted herein and shall be updated and amended, as necessary, by ordinance, adopted by the Board of County Commissioners. Disposal of residential and commercial solid waste is covered by the same service fees.

Section 2. The following new subsection (C) is hereby inserted as new material into Section 13(A) of Ordinance 2014-10:

(C) Free Solid Waste Disposal Days

The Board of County Commissioners may from time to time authorize by resolution the disposal of solid waste without the paying of service fees required by Section 13(A) of the Solid Waste and Recycling Management Ordinance under the conditions set forth herein. Any resolution authorizing the free disposal of solid waste shall specify (1) the day(s) on which solid

waste may be disposed of without paying service fees; (2) the type(s) of solid waste that may be disposed of without paying service fees; (3) the facilities at which specified solid waste may be disposed of without paying service fees, including the location of any roll off bins which may be place at a designated location within the County for use on the specified day without paying service fees; (4) limits (if any) on the amount of specified solid waste that may be disposed of without paying service fees; and (5) such other terms and conditions on the free solid waste disposal days as the Board of County Commissioners may determine to be necessary or proper.

Section 3. ORDINANCE REMAINS IN EFFECT, AS AMENDED. Except as expressly amended by Ordinance 2018-7, Ordinance 2020-2, Ordinance 2020-3 and further amended hereby, Ordinance No 2014-10 remains unchanged and in full force and affect.

Section 4. Effective Date

The effective date of this Ordinance shall be immediate after this ordinance is recorded with the County Clerk pursuant to NMSA 1978 § 4-37-9 as it is necessary for the public peace, health and safety that an ordinance take effect immediately after passage.
