AN ORDINANCE AMENDING SANTA FE COUNTY ORDINANCE NO. 2014-10 ("SOLID WASTE AND RECYCLING MANAGEMENT ORDINANCE"), AS AMENDED BY ORDINANCE 2018-7, TO ELIMINATE SCHEDULED INCREASE TO SOLID WASTE PERMIT FEES

BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF SANTA FE COUNTY THAT ORDINANCE NO. 2014-10, AS AMENDED, IS HEREBY FURTHER AMENDED AS FOLLOWS:

Section 1. Section 13(A)(B) is repealed and replaced with the following:

- (B) Schedule of Solid Waste Permit Fees
 - (1) 12 Trip Punch Permit: \$110.00.
 - (2) 6 Trip Punch Permit: \$55.00.
 - (3) 3 Trip Punch Permit: \$27.50.
 - (4) 1 Trip Permit: \$18.00.
 - (5) 5 Bag Tags: \$9.00.

Section 2. ORDINANCE REMAINS IN EFFECT, AS AMENDED. Except as expressly amended by Ordinance 2022-4, Ordinance 2020-3, Ordinance 2020-2, Ordinance 2018-7 and further amend hereby, Ordinance 2014-10 remains unchanged and in full force and effect.

Section 3. EFFECTIVE DATE. This Ordinance shall take effect thirty days after it is recorded by the County Clerk, pursuant to NMSA 1978, § 4-37-9.
