AN ORDINANCE AMENDING THE SANTA FE COUNTY SUSTAINABLE LAND DEVELOPMENT CODE ("SLDC"), ORDINANCE NO. 2016-9, TO AMEND THE SUSTAINABLE LAND DEVELOPMENT CODE, TO AMEND AND RESTATE APPENDIX F, MAP 2 (SANTA FE COMMUNITY COLLEGE DISTRICT CIRCULATION MAP) & APPENDIX C- MAP 5 – OFFICIAL MAP SERIES - (OPEN SPACE, TRAILS, AND PARKS) OF THE SUSTAINABLE LAND DEVELOPMENT CODE

BE IT ORDAINED BY THE SANTA FE COUNTY BOARD OF COUNTY COMMISSIONERS:

Appendix C, Map 5 (Open Space, Trails, and Parks) of the SLDC Official Map Series and Appendix F, Map 2 (CCD Circulation Map) of the SLDC is hereby amended and restated as follows:

1. SLDC Appendix F, Map 2 (Circulation Map) is hereby replaced with Exhibit A attached hereto.
2. SLDC Appendix C, Map 5 (Open Space, Trails, and Parks), is hereby replaced with Exhibit B attached hereto.
3. The effective date of this Ordinance shall be thirty (30) days after this Ordinance is recorded with the County Clerk.


