RESOLUTION NO. 2019-22

**A RESOLUTION
AUTHORIZING THE DISPOSITION OF
FIXED ASSETS IN ACCORDANCE WITH STATE STATUTE**

WHEREAS, Santa Fe County (“County”) desires to dispose of certain tangible personal property identified in Exhibit A, attached; and

WHEREAS, Exhibit A describes the item of tangible personal property - a fire department rescue vehicle - by its make, model, year, tag number, vehicle identification number, condition, estimated value, and location; and

WHEREAS, the County desires to donate the fire department rescue vehicle to Curry County for use by its volunteer fire department; and

WHEREAS, the Board of County Commissioners (“BCC”) determines that, pursuant to NMSA 1978, Section 13-6-2(D) (2007), (i) the fire department rescue vehicle has an estimated current resale value of five thousand dollars (\$5,000) or more; and (ii) the fire department rescue vehicle shall not be disposed until after the County receives the approval of the local government division of the department of finance and administration.

NOW, THEREFORE, BE IT RESOLVED that, pursuant to NMSA 1978, Section 13-6-2(D) (2007), the BCC (i) approves of the disposal of the fire department rescue vehicle by donation to Curry County for use by its volunteer fire department; (ii) directs that this resolution be transmitted for review and approval of the local government division of the department of finance and administration; and (iii) directs that, after the County’s receipt of approval by the local government division of the department of finance and administration, the fire department rescue vehicle shall be transferred to the ownership of Curry County, or otherwise disposed of as allowed by law.
