RESOLUTION NO. 2019 - 75**

A RESOLUTION RESCINDING SANTA FE COUNTY RESOLUTION NO. 2019-26

WHEREAS, on February 26, 2019, the Board of County Commissioners of Santa Fe County (“Board”) adopted Resolution 2019-26 selecting the proposal of New Mexico Fresh Foods, LLC (“NMFF”) to apply for a Community Development Block Grant (“CDBG”); and

WHEREAS, since the Board’s selection of the NMFF proposal, County staff and NMFF have been preparing the CDBG application; and

WHEREAS, as part of the CDBG application, County staff initiated the environmental review process by sending letters to multiple jurisdictions and government agencies requesting comment on NMFF’s proposal; and

WHEREAS, NMFF recently informed County staff that it will change both the location of its proposed facility from the County’s Community College District to the City of Santa Fe, and the source and scope of funding for the proposal, and accordingly, may change other aspects of its proposal; and

WHEREAS, the Board’s selection of NMFF’s proposal was based on representations made during the public hearings required by the applicable regulations for the CDBG process; and

WHEREAS, the Board believes that reinitiating the public hearings will ensure the transparency and integrity of the CDBG selection process; and

WHEREAS, County staff has informed the Board that NMFF intends to submit a revised proposal to apply for a CDBG.

NOW, THEREFORE, BE IT RESOLVED by the Board that Resolution No. 2019-26 is hereby rescinded.
