**A RESOLUTION ADOPTING THE FINAL BUDGET  
FOR FISCAL YEAR 2019-2020 (FY 2020)**

**WHEREAS**, the Board of County Commissioners of Santa Fe County (“Board”) reviewed the Interim Budget for Fiscal Year 2019-2020 (FY 2020), at its regular meeting on May 28, 2019, which was noticed as required by the Open Meetings Act, NMSA 1978, Section 10-15-1 et seq., and Resolution No. 2017-143; and

**WHEREAS**, at its May 29, 2019 meeting, the Board adopted Resolution No. 2018-53 approving the Interim Budget for FY 2020; and

**WHEREAS**, the County Finance Department, in preparing the Final Budget for Fiscal Year 2019-2020 (FY 2020), made changes to the budget based upon the Board’s direction at its May 28, 2019 meeting, as well as certain technical changes; and

**WHEREAS**, the Board reviewed the Final Budget for Fiscal Year 2019-2020 (FY 2020) at its regular meeting on June 25, 2019, which was noticed as required by the Open Meetings Act, NMSA 1978, Section 10-15-1 et seq., and Resolution No. 2017-143.

**NOW, THEREFORE, BE IT RESOLVED** by the Board that the Final Budget for Fiscal Year 2019-2020 (FY 2020), beginning on July 1, 2019, and ending on June 30, 2020, is hereby adopted, and the Board respectfully requests its approval by the Local Government Division of the New Mexico Department of Finance and Administration.

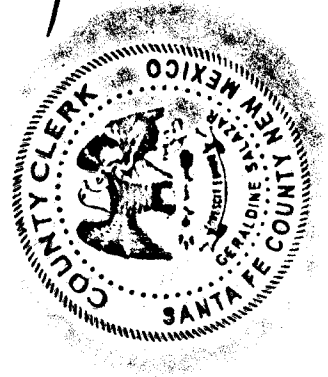
