A RESOLUTION DONATING SURPLUS FIRE DEPARTMENT FIRE EQUIPMENT TO OTHER FIRE DEPARTMENTS IN NEW MEXICO

WHEREAS, section 13-6-1 NMSA 2007 authorizing the donation of old or outdated property to other fire departments; and

WHEREAS, the Santa Fe County Fire Department has received new fire, rescue, EMS equipment and apparatus to replace old and outdated equipment and apparatus; and

WHEREAS, the citizens of Santa Fe County have been generous in their support of the Santa Fe County Fire Department in providing new and updated equipment and apparatus that meet the current needs and standards; and

WHEREAS, the certain old fire and rescue equipment does not meet current County standards and some state and federal agency standards; and

WHEREAS, the fire and rescue equipment has an estimated current resale value of five thousand dollars (\$5,000) or less; and

WHEREAS, the Santa Fe County Fire Department, whenever possible, attempts to assist other fire departments in the State of New Mexico by donating old or outdated equipment and apparatus; and

WHEREAS, some rural fire departments need used fire equipment; and

WHEREAS, certain fire departments desire to obtain this equipment and apparatus and put it to good use in service of the public safety needs of their respective communities; and

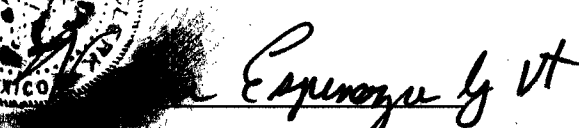
1 WHEREAS, these Fire Departments have made their requests and needs known through

4 SANTA FE COUNTY that:

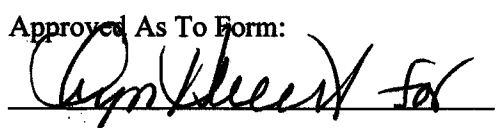
5 Section 1. The County hereby donates to the Harding County Fire Department,
6 Harding County, one (1) 1978 Dodge Brush Truck Vin: W24D8S2733373, License: G09551.

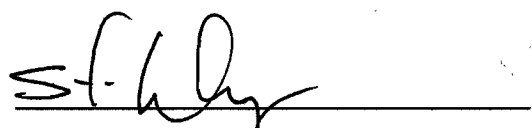

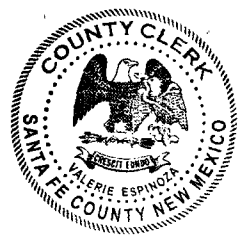

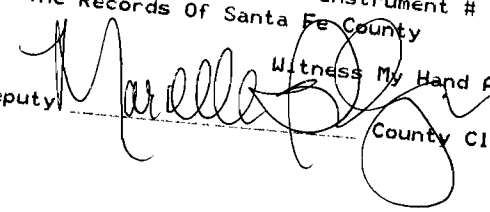
