A RESOLUTION REQUESTING FUNDING THROUGH THE 2008/2009 LGRF PROGRAM NEW MEXICO DEPARTMENT OF TRANSPORTATION

WHEREAS, the Board of County Commissioners (hereafter referred to as "the Board") desires to utilize funding made available through an application submitted to the New Mexico Department of Transportation's LGRF (Local Government Road Fund) Program for various County road improvement projects; and

WHEREAS, upon approval of the application submitted to the New Mexico Department of Transportation (hereafter referred to as "the Department") funding will be received in the form of Cooperative Agreement - SB; and

WHEREAS, the Department requires that the Board provide a Resolution requesting funding and attach a detailed project breakdown per funding source; and

WHEREAS, a detailed project breakdown, together with the agreed County match, is set forth on Exhibit "A" herein for County Road 42 Improvement projects,

NOW THEREFORE, the Board of County Commissioners hereby requests funding for the project set forth in Exhibit "A" for the 2008/2009 New Mexico Department of Transportation's LGRF Program based on the requested project amount and quantities listed therein.

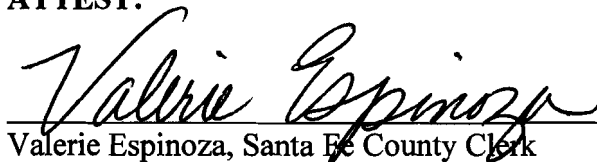

The request for the SB Funding will incorporate the full construction of 0.82 mile of unpaved road for Phase I on Santa Fe County Road 42. This section of road lies between STA 10+00 and STA 53+32.67. Construction on this section to utilize two eleven foot driving lanes includes:

- Earthwork
- Drainage structures
- Erosion control structures
- Vertical realignment
- 6" Lime treatment subgrade
- 6" Type I base course
- Prime coat
- 3" PMBP
- Traffic Stripping
- Traffic Signage
