WHEREAS, the County is currently working with the property owner to develop a lease agreement but the necessary documents will not be finalized in time for the October 28, 2008 Board of County Commissioners meeting;

WHEREAS, the County wishes to allow for a timely and efficient process for the required temporary parking and office space;

WHEREAS, the Board desires to lease the property during the construction of the new court facility and authorizes the County Manager to execute any and all documents necessary to effectuate the lease of property to provide temporary parking and office space.

NOW, THEREFORE BE IT RESOLVED AS FOLLOWS:

The County Manager is authorized to execute all relevant documents concerning the lease agreement to provide for temporary parking and office space during the construction of the new First Judicial District Courthouse facility.
