A RESOLUTION APPROVING SALARY INCREASES FOR SANTA FE  
COUNTY ELECTED OFFICIALS

---

**WHEREAS**, the 2006 New Mexico Legislature amended NMSA 1978, § 4-44-4 authorizing the increase of salaries for elected officials;

**WHEREAS**, the New Mexico Department of Finance and Administration, Local Government Administration, has certified Santa Fe County as a Class A County;

**WHEREAS**, NMSA 1978, § 4-44-12.3(B) establishes the authority of the Board of County Commissioners to adopt, by resolution, the increases in annual salaries of elected officials of Class A Counties;

**IT IS THEREFORE RESOLVED, AS FOLLOWS:**

The Board of County Commissioners declares that the salaries for newly elected officials, in accordance with NMSA 1978, §§ 4-44-4 (2006) and 4-44-12.3 (1999), be as follows:

- A. county commissioners, twenty-nine thousand five hundred sixty nine dollars (\$29,569) each;
- B. treasurer, sixty-five thousand five hundred one dollars (\$65,501);
- C. assessor, sixty-five thousand five hundred one dollars (\$65,501);
- D. sheriff, sixty-eight thousand three hundred eight dollars (\$68,308);
- E. county clerk, sixty-five thousand five hundred one dollars (\$65,501);
- F. probate judge, twenty-eight thousand eight hundred twenty dollars (\$28,820); and
- G. county surveyor, nineteen thousand four-hundred forty-two dollars (\$19,442).
