RESOLUTION NO. 2008- 200

**A RESOLUTION AUTHORIZING THE COUNTY MANAGER TO EXECUTE
CONTRACTS FOR RFP #29-0060-CSD/HGR FOR WATER TREATMENT DURING
CONSTRUCTION OF THE NEW STEVE HERRERA DISTRICT COURTHOUSE**

WHEREAS, Santa Fe County ("the County") has undertaken the construction of a new court facility to house the Steve Herrera District Courthouse on approximately 2.4 acres of property ("the Property") owned by the County at the corner of Montezuma Avenue and Sandoval Street in Santa Fe;

WHEREAS, construction of the new court facility will require dewatering of the site during the excavation and initial construction of the building, lasting approximately 7 months;

WHEREAS, hydrocarbons that have migrated from adjoining properties are present in the groundwater that will be pumped during the dewatering process and the water will require filtering treatment prior to discharge;

WHEREAS, the County has issued RFP #29-0060-CSD/HGR to solicit water treatment services but the contract will not be finalized prior to the November 18, 2008 meeting of the Board of County Commissioners;

WHEREAS, the County wishes to allow for a timely and efficient process for the courthouse construction and it is necessary to procure the water treatment services prior to excavation activities commencing; and

WHEREAS, the Board desires to obtain the water treatment services described and authorizes the County Manager to execute any and all documents necessary to effectuate an award for RFP #29-0060-CSD/HGR for water treatment services.

NOW, THEREFORE BE IT RESOLVED AS FOLLOWS:



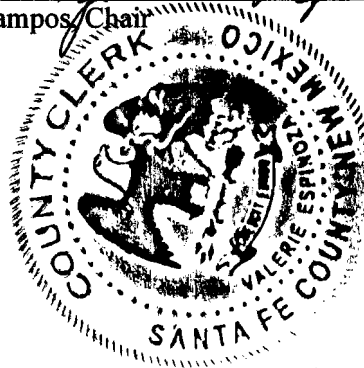


