**A RESOLUTION AUTHORIZING THE COUNTY MANAGER TO EXECUTE
CONTRACTS FOR RFP #29-0042-CSD/HGR FOR MATERIAL TESTING AND
SPECIAL INSPECTION SERVICES FOR CONSTRUCTION OF THE NEW STEVE
HERRERA DISTRICT COURTHOUSE**

WHEREAS, Santa Fe County ("the County") has undertaken the construction of a new court facility to house the Steve Herrera District Courthouse on approximately 2.4 acres of property ("the Property") owned by the County at the corner of Montezuma Avenue and Sandoval Street in Santa Fe;

WHEREAS, construction of the new court facility will require various material tests and special inspections during construction of the building;

WHEREAS, the County has issued RFP #29-0042-CSD/HGR to solicit for material testing and special inspection services but the contract will not be finalized prior to the December 9, 2008 meeting of the Board of County Commissioners;

WHEREAS, the County wishes to allow for a timely and efficient process for the courthouse construction and it is necessary to procure for the material testing and special inspection services prior to construction activities commencing; and

WHEREAS, the Board desires to obtain the services described and authorize the County Manager to execute any and all documents necessary to effectuate an award for RFP #29-0042-CSD/HGR for material testing and special inspection services.

NOW, THEREFORE BE IT RESOLVED AS FOLLOWS:

The County Manager is authorized to execute all relevant documents concerning the award and subsequent contracting of RFP #29-0042-CSD/HGR for material testing and special inspection services for the new Steve Herrera District Courthouse.
