**A RESOLUTION AUTHORIZING THE COUNTY MANAGER TO EXECUTE  
CONTRACTS AND EASEMENTS CONCERNING CONSTRUCTION OF  
IMPROVEMENTS TO THE SANTA FE COUNTY RAIL TRAIL**

**WHEREAS**, Santa Fe County ("the County") has undertaken the construction of improvements to the County owned Rail Trail including approximately 11 miles of trail between Rabbit Road and the village of Lamy that will allow for greater trail user safety, improved trail drainage, improved trail surface conditions and enhanced trail user experience;

**WHEREAS**, the trail is currently within an easement owned by the County in the Right-Of-Way of the Santa Fe Southern rail line that is owned by the State of New Mexico and the planned improvements will require modifications to the existing easement and staff have coordinated the easement modifications with the New Mexico Department of Transportation but the necessary documents will not be finalized in time for the December 9, 2008 Board of County Commissioners meeting;

**WHEREAS**, the planned improvements will require contracts for the construction but the necessary documents will not be finalized in time for the December 9, 2008 Board of County Commissioners meeting;

**WHEREAS**, the County wishes to allow for a timely and efficient process for the construction of the improvements to the Santa Fe County Rail Trail;

**WHEREAS**, the Board desires to construct the improvements to the Santa Fe County Rail Trail and authorizes the County Manager to execute any and all documents necessary to effectuate the modification to the easement and contracts to construct the improvements

**NOW, THEREFORE BE IT RESOLVED AS FOLLOWS:**

The County Manager is authorized to execute all relevant documents concerning the modification to the easement and contracts to construct the improvements to the Santa Fe County Rail Trail
